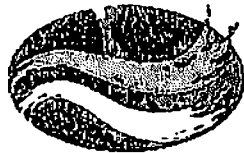

Effective June 1, 2012, all administration, enforcement and permit issuance related to the storm water and erosion control program will take place in the Planning and Zoning Office located in the County Administration Building, 112 Otter Ave, 3rd Floor, Oshkosh, WI 54901.

Brent Jalonen will be transferred to the Planning and Zoning Office and will be responsible for permit issuance, inspections, enforcement and general inquiries regarding storm water management and erosion control. In keeping with the established hours of the Planning and Zoning Office, walk-in hours for permits and questions will be Monday through Friday 8-10 am or by appointment. These hours will allow residents to obtain erosion control, storm water, sanitary and zoning permits in one location. It is our anticipation this change will better serve the general public.

Please remember this office requires a 24-hour notice for inspections. Brent Jalonen's telephone number is (920) 232-3331. **All messages should include the property owner's name, the erosion control permit number and the property address. The caller must leave a name and number as well should Brent need to contact that person.**

RE: New Location for Erosion Control / Stormwater Permits.

Effective January 1, 2010, all erosion control / stormwater permits will be issued at the Land and Water Conservation Department (LWCD). The LWCD is located at **625 E County Rd Y, Oshkosh**. Previously, the LWCD had issued erosion control permits for new single family dwellings for certain towns. The LWCD will be responsible for issuance of all erosion control / stormwater permits and subsequent enforcement in all towns except **Menasha and Omro**. Project escrows related to commercial drainage plans will still be handled by the Planning Department. Inquiries, complaints, inspection requests and / or violations regarding erosion control / drainage must be directed to the LWCD. The phone number is **(920) 232-1950**.

This office hopes to provide better service to the public by having all erosion control / stormwater permits issued by one department. **The erosion control / stormwater permit must be issued before a zoning permit can be issued.** Your assistance in this matter is appreciated.
